The undersigned, being duly sworn upon his oath, says that on or about June 7, 2023, in Rush County, State of Indiana, Patrick Scott did knowingly or intentionally kill another human being, to-wit: Valerie Tindall, contrary to the form of the statutes in such cases made and provided by I.C. 35-42-1-1(1) and against the peace and dignity of the State of Indiana.

Count 2:


The undersigned, being duly sworn upon his oath, says that between June 7, 2023, and November 28, 2023, in Rush County, State of Indiana, Patrick Scott did alter, damage or remove record, document or thing, with the intent to prevent said item from being produced or used as evidence in a criminal investigation, contrary to the form of the statutes in such cases made and provided by I.C. 35-44.1-2-2(a)(3) and against the peace and dignity of the State of Indiana.

Count 3:

The undersigned, being duly sworn upon his oath, says that on or about June 10, 2023 in Rush County, State of Indiana, Patrick Scott did give false information to a law enforcement officer relating to the commission of a crime, to-wit: gave a statement to RCSD Deputy Joshua Brinson that he had not seen Valerie Tindall, who had been reported missing, knowing said information to be false,

said act resulting in a substantial hindrance to a law enforcement process, contrary to the form of the statutes in such cases made and provided by I.C. 35-44.1-2-3(d)(1) and against the peace and dignity of the State of Indiana.
