

MEMORANDUM IN SUPPORT OF APPLICATION FOR APPOINTMENT OF SPECIAL ADMINISTRATOR

BACKGROUND

)

Petitioner is the sister of the Decedent, Mica Acacia Miller, who died on April 27, 2024, under what is being referred to as suspicious circumstances, which are currently being investigated by Robeson County authorities.¹ Just prior to her death, on April 15, 2024, the Decedent filed for divorce from her husband, John-Paul Jones.² On April 25, 2024, Decedent's husband was duly served with a copy of the family court proceedings. Then, on April 27, 2024, Petitioner was found deceased.

A hearing as to Decedent's Motion for Temporary Relief in the family court proceedings has been scheduled for June 5, 2024.³ Petitioner seeks to be appointed as Special Administrator for the Estate of Mica Acacia Miller for two specific purposes: (1) to preserve the Decedent's interest in the martial estate; and (2) to determine whether a Last Will & Testament exists, as further described below, and in the attached Exhibits.

1. Petitioner seeks to be appointed as Special Administrator in order to preserve the Decedent's interest in the martial estate.

Though the Decedent's claims for divorce and support would have abated upon her death, the claim for equitable apportionment as to the marital estate remains. *See Hodge v. Hodge*, 305

S.C. 521 (Ct. App. 1994); see also Seels v. Smalls, 437 S.C. 167 (2022) (holding that the family court property retained jurisdiction to rule on an action seeking equitable apportionment of martial property after one of the parties died during the pendency of the action). To preserve the Decedent's interest in the marital estate, Petitioner seeks to be appointed as Special Administrator for the purpose of moving to be substituted as Plaintiff in the family court action. Decedent's interest in the material estate vested at her filing the family court action and can be collected by a representative of her estate.

As mentioned briefly above, Plaintiff's Motion for Temporary Relief is scheduled for **June 5**, 2024, before the Honorable Jan Bromell Holmes. It is of the particular importance for Petitioner to appear and obtain a *pendente lite* order restraining and enjoining Mr. Miller from disposing, encumbering, transferring, selling, hypothecating, pledging, destroying, or otherwise altering the status or value of any marital asset.

It would be impractical for Mr. Miller be appointed as Special Administrator, or Personal Representative, of the Decedent's estate as he has a pecuniary interest in the outcome of such a claim regarding the marital estate. It is prudent for a third-party to be appointed for this purpose to ensure that the results are equitable to those involved.

2. Petitioner seeks to determine whether Decedent has a Last Will & Testament and would seek to use subpoena powers granted to her in her authority as Special Administrator to do so.

Petitioner is aware through the creation and filing of Decedent's Power of Attorney⁴ that some level of estate planning exists. What Petitioner does not know, and currently has no grounds under which to inquire into further, is whether part of this estate planning included the preparation and signing of a Last Will & Testament, which could impact Decedent's estate.

While Decedent's estranged husband might know the answer to this question, if the answer to whether she had a Will was answered in the affirmative and such would not benefit him, due in large part to allegations of abuse and the pending divorce proceedings, he would be better served through intestate succession, which would make him the sole heir to Decedent's estate. Had Decedent created a Will and sought to limit her estranged husband's share of same, or disinherit him entirely, is what Petitioner seeks to determine, by requesting any such relevant estate planning documents. This is especially relevant as to Petitioner's need to preserve the Decedent's interest in the martial estate and the subsequent distribution of same.

3. Finally, both for those reasons mentioned above, and due to John-Paul Miller's potential exclusion from benefiting from Decedent's estate under S.C. Code § 62-2-803, it would be improvident to give him control over the Decedent's estate, despite the two still being legally married.

As initially mentioned, the investigation into the circumstances surrounding the Decedent's death are still being actively investigated by law enforcement. Circumstances exist to indicate that John-Paul Miller may be a person of interest in connection with his wife's death, but that will take law enforcement additional time to determine. If he is convicted of having a role in her death, this would preclude him from benefiting from the Decedent's estate, pursuant to S.C. Code § 62-2-803, more colloquially known as the "Slayer Statute." However, in the absence of such a conviction or guilty plea establishing the criminal accountability for the Decedent's death, S.C. Code § 62-2-803(f) allows a court, upon the petition of an interested person to "determine whether, upon the preponderance of the evidence standard, the individual would be found responsible" for the death. Although this is yet to be determined, it is still an important factor in Petitioner's request to be appointed, as the possibility of his disqualification creates the implication that he would not act in the best interest of the Decedent's estate. See the

enclosed Affidavits⁵ of Sierra Francis and Nathaniel Francis as supporting evidence of the potential for culpability in the Decedent's death. Additionally, prior to her death, Decedent sought a restraining order against John-Paul,⁶ though it is believed the restraining order was ultimately not issued.

Conclusion

Therefore, based on the foregoing, the Petitioner respectfully requests that the Court issue an order appointing her as Special Administrator of the Decedent's estate.



He said, at this point, the investigation has not revealed any information that indicates there is a danger to the community following her death.





PERSONALLY appeared before me, Sierra Francis, who, after first being duly sworn deposes and states as follows:

- 1. I am the Petitioner in the proceedings which are pending before the Probate Court as to the appointment of a Special Administrator for my sister's estate.
- 2. I am Mica's younger sister, having been raised by our parents, Michael Francis and Angelita Salas, with our siblings Nathaniel, Destinee, Anna and Abi.
- 3. We ultimately settled in Myrtle Beach, South Carolina in 2007, with our mom and step-dad.
- 4. I was aware of Mica's family dynamics and relationship with her husband, Respondent John-Paul Miller, and step-children, Selah, Asher, Logan, Eli and Zack.
- 5. Mica and I spoke every few days, texting daily, so much as to even create playlists together. Mica would drive to visit me and my family in Gaffney, South Carolina at least once a month.
- 6. I know my sister to have expressed the abuse and violence against her by her husband to others, including family members and members of the church congregation.
- 7. Mica told me that there were people following her, keeping track of where she went. She thought that Mr. Miller hired people to follow her. Mr. Miller later confirmed this during a sermon I watched.
- 8. Mica confided in me that Mr. Miller was moving assets that were in his name, such as his vehicle, changing the Deed to their house to the church, transferring interest in Crocodile Rocks to one of his sons.
- 9. In February 2024, Mr. Miller removed my sister's personal items from the home they shared while she was admitted to Waccamaw Mental Health facility and left them at the apartment of Dianna Niosi. My sister was not aware that her personal possessions had been removed from her residence until she was released from the hospital.
- 10. Prior to her admission to Waccamaw, Mica was gathering and sorting the evidence she had to

bring to an attorney for filing for divorce, to support her claims against Mr. Miller, and as to his abuse, character, his paramours, and associates he "paid off" or blackmailed. While at the facility, those documents, emails, files, etc., were removed from her phone, personal laptop, vehicle and purse and never recovered. Further, Mica was unable to access her iCloud account, email, or Facebook profile. Mr. Miller continued using at least one of Mica's accounts, causing any recipient to believe it was Mica's communications.

- 11. Mica talked about what she wanted her life to be like following her divorce from Mr. Miller. Having traveled for a church mission this past fall, from October 15 through October 27, 2023, Mica was intending to participate in additional missions, even to live part-time in Kenya. Mica recently shipped some of her personal items to Kenya in preparation of her stay there.
- 12. My sister was hopeful for her future after filing for divorce from John-Paul.
- 13. My sister also expressed to me that she was fearful that she would not make it to the divorce and that her life would be taken from her. It is my belief based on conversations with my sister that she told multiple people, including other family members.
- 14. Mica stated to me on many occasions "if I end up with a bullet in my head, it was not by me, it was JP".
- 15. Mica forwarded a family group text message notifying us that Mr. Miller was served the divorce papers on April 25, 2024.
- 16. On April 27, 2024, my sister, Mica A. Miller, was found dead as a result of a gunshot wound in Lumberton, North Carolina.
- 17. I have the full support of my family in my request to be appointed as Special Administrator. I take this request and my potential appointment in this role very seriously.

AFFIDAVIT OF NATHANIEL FRANCIS (in support of Application for Application of Special Administrator)

PERSONALLY appeared before me, Nathaniel Francis, who, after first being drives sworn, deposes and states as follows:

- 1. I am the brother of Petitioner, Sierra Francis, and Decedent, Mica A. Miller, in the proceedings which are pending before the Probate Court as to the appointment of Sierra Francis as Special Administrator for my sister Mica's estate.
- 2. I am Mica's only brother, having been raised by our parents, Michael Francis and Angelita Salas with our siblings Destinee, Sierra, Anna, and Abi in Wichita, Kansas.
- 3. My mom and my siblings, apart from our oldest sister, Destinee, moved to Horry County in 2007.
- 4. I was aware of Mica's family dynamics and relationship with her husband, John-Paul Miller, and step-children, Asher, Selah, Eli, Zack, and Logan.
- 5. I saw Mica frequently, as we both lived in Horry County, and spoke to her on a weekly basis.
- 6. I was also a member of Solid Rock, where both John-Paul and Mica worked, for several years until I left the congregation due to the behaviors I observed.
- 7. Mica confided in me that John-Paul moved her belongings out of their marital residence and in with Dianna Niosi, so that he could "keep an eye on her." Following this, Mica then retained an attorney for the purposes of filing for divorce from her husband and joined a new church.
- 8. I have received communications in the past from John-Paul Miller, stating that he knew no reason for divorce, but wanted a separation and gave reasons why. The email I received on April 3, 2023, included a forwarded email from Mr. Miller to Mica dated April 1, 2023, to an email address that did not appear to be Mica's.¹ Just two (2) weeks later, Mica forwarded me an email from Mr. Miller dated April 15, 2023, to her correct email address, as shown.²

- Mica told me of legal documents she prepared so that I would be able to make decisions for her well-being. However, those documents were not located. The only legal documents discovered appointed Mr. Miller as her power of attorney.
- 10. Mica made several police reports over the last few weeks of her tires being slashed and tracking devices being found on her car. In Mr. Miller's email forwarded to me, he apologizes to Mica for the tires and causing damage to her vehicle.
- 11. Mr. Miller's email to my sister continued to state that he was angry when Mica confided or "put her family before" him and that made him want to hurt her. In his words "When someone hurts me, I try to hurt them back rather than forgive." and "instead of me forgiving you.... I just attack and try to cause pain."
- 12. Mica told me on numerous occasions that she feared John-Paul and just wanted to escape him.
- 13. Our family is very supportive of one another, and especially in this time of grieving. I believe that my sister Sierra is the appropriate person to step into Mica's shoes and continue what was started by her, both to secure her assets, and to determine her portion of the marital estate.
