A. Documents 101 - Basics of 18 USC §§ 793(e) and (f)

-high-level conversation with Kel McClanahan and we didn't go back over the basics because a bunch of people wrote in to say "I thought you made a big deal about commingling, with the Trump documents being next to his passport?" And that's true, but it's true because of the only fact that matters.

Trump still doesn't want to give them back.

So, let's be clear.

18 USC § 793(f) applies to Trump https://www.law.cornell.edu/uscode/text/18/793

Whoever, being entrusted with or having lawful possession or control of any document, writing, code book, signal book, sketch, photograph, photographic negative, blueprint, plan, map, model, instrument, appliance, note, or information, relating to the national defense, (1) through gross negligence permits the same to be removed from its proper place of custody or delivered to anyone in violation of his trust, or to be lost, stolen, abstracted, or destroyed, or (2) having knowledge that the same has been illegally removed from its proper place of custody or delivered to anyone in violation of its trust, or lost, or stolen, abstracted, or destroyed, and fails to make prompt report of such loss, theft, abstraction, or destruction to his superior officer—

Shall be fined under this title or imprisoned not more than ten years, or both.

That first clause -- § 793(e) applies when you *don't* have authorized possession; that could be Biden if it was after Jan. 20th. So it's either (e) or (f). But under both you have the same elements and you have to prove all three:

- -(1) you have documents relating to the national defense
- -(2) you know that they've been taken from where they belong
- -(3) you don't return them

Both have that same element.

So let's check in with Biden.

- (1) Yes unequivocally, he had documents related to the national defense
- (2) Unsure if he knew they'd been taken from where they belong the degree of commingling *does* suggest this
- (3) uh

-so yes, commingling relates to proving that the documents are not where they're supposed to be; element (2). But so long as Biden doesn't secretly have other documents that he's refused to turn over, you can't prove (3).




